All this to serve her purpose in life and that may be to slow me down within the moment.

River came in to our live December 22, 1999 just in time for Christmas


He was a dear very sweet boy who more than lived up to all expectations (which were

My little daughter went crazy barking at those loud noises on July 4th. How can I tell her the noises will not harm her? Now she looks around and heads for the safety of her crate or under the bed when she hears any loud noise.

Dear Sparky,

The best ways I have found to create an environment of safety for those dogs that are frightened by the noise of the firecrackers are as follows:

1) Remove the dog from the noise. Go to a basement or interior space, close windows, turn on radio and/or TV, run a fan or two. 2) Play ball or other favorite games with them in an area where the noise is reduced or absent and where they feel safe. The distractor factor works well if there is a game they love to play. 3) Don't make a big deal of the noise or the "fear" of it; don't coddle them. 4) The "Thunder Shirt" seems to work. You can buy them at most pet supply stores. Or if you are caught in a situation without the special shirt; try putting a tight fitting Tshirt or tank top on the dog. Often this will make them feel safe too. It would be a good idea to be prepared for the next noisy time; usually New Years Eye.

My little sister has been kennel trained and doesn't seem to mind her crate. My people always gave her lots of toys, toys filled with treats and other safe chew toys to get her used to her kennel. Now that she has grown up a little, my canine friends and I would like to have her out of the kennel so we can play and teach her things. Do you have any advice on how to trust her out of her kennel?

Dear Jus,

I can appreciate that you all want to play. It will be up to your people to decide when or if the little darling gets to be out of the kennel while they are way. Some people are ok with dogs out and about and others feel safer with dogs contained for the safety of all. If your people want to leave the pup out of the kennel, tell them to leave her for only short periods of time at first (minutes) and extend the freedom over time. It is always tricky to trust the pups. Make sure your people remove anything that could be dangerous if she got into it. I remember when my little nephew was showing us that he was trustworthy, so he was granted kennel free days. Then one day he shredded the bottom of the sofa. So it is not easy to determine when – if ever- certain pups can be granted that freedom.



Vestibular Disease

Jill Floberg shared this article about a condition that she has experienced with her beardies, recently with River. Vestibular disease can resolve itself given enough time depending on the underlying cause!

Common Conditions

Vestibular Disease

- Vestibular disease is a medical condition that affects the nervous system.
- Clinical signs of vestibular disease include incoordination (instability when trying to stand or walk), head tilt, and circling to one side.
- Sometimes the cause of vestibular disease remains undiagnosed, but underlying causes can include thyroid disease (in dogs) or a middle/inner ear infection.
- Spontaneous recovery from vestibular disease often occurs.

What Is Vestibular Disease?

Vestibular disease is an illness that affects a group of small organs called the vestibular apparatus. The vestibular apparatus is located in the brain and inner ear. These organs are responsible for an animal's ability to remain balanced, detect the degree of head rotation, and determine overall body position. Vestibular disease can result if the vestibular apparatus is damaged.

Vestibular disease can be caused by a middle or inner ear infection, tumors involving the middle or inner ear, brain tumors, or head trauma. Thyroid disease has been associated with vestibular disease in dogs, and certain medications can cause vestibular disease-like clinical signs. Sometimes the underlying cause remains undiagnosed; this is referred to as idiopathic vestibular disease.

Vestibular disease tends to affect older dogs, but cats can be affected earlier in life.

Clinical Signs of Vestibular Disease

When there is an issue with the vestibular apparatus, the pet loses the ability to maintain balance. Clinical signs can occur very suddenly and can be so severe that the pet us unable to walk, stand, or move.

The following are signs of vestibular disease:

- Incoordination (instability when trying to stand or walk)
- · Rapid eye movement from side to side

- Circlin
- · Head tilt
- · Rolling or falling to one side
- · Vomiting

Diagnosis

The diagnosis of vestibular disease involves a physical examination and a neurologic examination (specific physical examination "tests" used to assess the patient's nerve and brain function). Your veterinarian will likely examine the ear canal to see if there is evidence of an infection or tumor. X-rays of the skull may also show tumors or evidence of fluid or inflammation in the middle or inner ear.

Clinical signs of vestibular disease include incoordination (instability when trying to stand or walk), head tilt, and circling to one side.

Some veterinarians have access to sophisticated equipment for computed tomography (CT) and magnetic resonance imaging (MRI), which can provide detailed images of the brain and inner ear. If this equipment is not available, diagnosis is based largely on clinical signs and physical examination findings.

Treatment

The goal of treatment is to address the underlying problem and keep the animal as comfortable as possible until recovery is adequate. If the patient is suffering from an ear infection, the infection should be treated. Sometimes, a course of antibiotics is given. Other treatments are aimed at controlling nausea/vomiting and providing comfort until the patient recovers. Severely affected pets may require hospitalization until they can eat and drink as well as stand without falling.

Many patients recover from vestibular disease within 14 days of the onset of clinical signs, with or without treatment. Occasionally, a slight head tilt may remain, but many patients recover completely. If the underlying cause of the episode was a tumor

of the brain or inner/middle ear, the outcome depends largely on whether the tumor can be treated. Similarly, if the underlying cause was an ear infection or thyroid problem, recovery depends on effectively managing these problems.
